The main features

 - The single investment option is designed for clients looking to invest in a managed portfolio with a discretionary fund manager, stockbroker, or fund platform.
 - The full investment option unlocks the SIPP's complete investment flexibility.
- Access to SIPPView online providing valuations, financial transactions history, asset holdings and benefit information.
- Anyone may be a member, including minors, the unemployed and retired; there is no minimum or maximum age.
- Following an initial contribution, or a transfer of existing pension funds, there is no ongoing requirement to pay contributions.
- A bespoke service provided by a dedicated SIPP Administrator who works in a supportive team environment.
- Administration services that are monitored against demanding processing timescales and results that are published monthly.
- Retained solicitor used for property investments.
- Access to the Rowanmoor Property Insurance Policy.
